IMPORTANT INFORMATION TO THE APPLICANTS APPLIED FOR THE POSTS OF PROFESSOR AND ASSOCIATE PROFESSOR IN VARIOUS DISCIPLINES

1. The University had advertised the posts of Professor and Associate Professor in various disciplines vide **Employment Notice No. 002/2015** dated **19th May, 2015**.
2. In response to the said Advertisement, the University had received a large number of applications for the posts of Professor and Associate Professor in various disciplines.
3. These applications were screened by the Screening Committee on 2nd September, 2015 onwards. The Screening Committee checked and verified the records of each applicant and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Employment Notice No. 002/2015 dated 19th May, 2015; UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010; UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education (2nd Amendment) Regulations 2013 and NCTE Regulations 2010 as amended up to date.

4. Since the number of eligible applicants for the positions of **Professor and Associate Professor** in each discipline is not very large, the Screening Committee decided that all eligible applicants who meet the minimum eligibility requirements may be short-listed to be called to appear before the Selection Committee for Expert Assessment and Interview. **IMPORTANT: Selection Committee shall not be held in all such disciplines where the numbers of eligible candidates is less than three and that these positions shall be re-advertised.**
5. Discipline-wise complete list of all applicants who have applied for the positions of **Professor in various disciplines**, giving their critical information and decision of the Committee with regard to their eligibility and non-eligibility along with the reasons thereof is placed at **ANNEXURE – A**.
6. Discipline-wise complete list of all applicants who have applied for the positions of **Associate Professor in various disciplines**, giving their critical information and decision of the Committee with regard to their and non-eligibility along with the reasons thereof is placed at **ANNEXURE – B**.
7. **It may be noted that:**
 - a. Decision with regard to Short-listing of applicants to be called to appear before the Selection Committee for Expert Assessment and Interview, has been made on the basis of their claim/information/certificates furnished/attached in their application forms.
 - b. Further, while deciding as to whether an applicant is to be called to appear for Interview before the Selection Committee, benefit of doubt has been given to the candidates, in case of any ambiguities with regard to educational qualification, experience, percentage of marks, category etc.
 - c. Applicants shall have to substantiate their claim through documentary proof **at the time of the Interview**.
 - d. Applicants must ensure that their details are correct and that they meet the minimum eligibility requirements, failing which they shall not be allowed to appear for Interview before the Selection Committee.
 - e. The eligibility of the applicants has been determined as on the **last date of receipt of applications** as per the Advertisement for the posts.
8. Although all efforts have been made to ensure accuracy in preparing the list mentioned at Para 5 & 6 above, possibility of inadvertent error or typographical mistake / omission cannot be ruled out. The University will incorporate the genuine and justified requests, if any, on receipt from applicants. Therefore, the applicants are advised to go through their details carefully and in case of any discrepancy, the applicants are advised to bring the same to the notice of the University for necessary correction(s) clearly mentioning the name of post, name of the discipline, Ref. No. at which their names figures in the list by writing an E-mail to cuhp.fr@gmail.com latest by **6TH NOVEMBER, 2015**.
9. **NO REQUEST FOR CORRECTIONS AND / OR IMPROVEMENT SHALL BE ENTERTAINED AFTER 6TH NOVEMBER, 2015.**
10. Only genuine and justified requests for corrections and / or improvement in qualification shall be incorporated.
11. Important Information with regard to applicants who have applied for the post of Assistant Professor in various disciplines is being processed and will be displayed on the University Website separately. **Applicants are advised to check the University Website regularly.**
