 - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - i. Marksheets of Matriculation and 10+2.
 - ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
 - iii. Kashmiri Migrant Certificate, if applicable.

- iv. Persons with Disabilities Certificate, if applicable.
- (b) Original Documents to be submitted:
- i. Character Certificate
 - ii. Affidavit by student for intervening period/ over a gap of three years, if applicable
 - iii. Employer's no objection certificate, if applicable
 - iv. Two Passport size photographs.

The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
