- **Post:** one
- **Salary:** NET/GATE qualified candidate: Rs. 16,000/-p.m. for initial two years and Rs. 18,000/-p.m. for the third year.  
  
Non-NET/GATE candidates: Rs. 14,000/-p.m. for initial two years and Rs. 16,000/-p.m. for the third year.  
  
The project fellow will be also entitled for getting HRA as per university rules.
- **Tenure:** 3 years. The post is temporary and co-terminus with the Project on **01/07/2018**.
- **Essential Qualification:**
  1. Master degree in Bioinformatics/Biochemistry/Biotechnology/Environmental Science/Microbiology or any branch of Life Sciences with a minimum of 55% marks for general category (50% in case of SC/ST/PH)
  2. UGC/CSIR NET, GATE qualified candidates will be given preference.
- **Desirable Qualification:** Experience in basic Bioinformatics and Molecular Biology techniques
- **Age:** Below 40 years as on 01/10/2015.
- Relaxation in educational qualifications/upper age limit is admissible for SC/ST/OBC/PH candidates as per UGC guidelines/GOI rules.
