

## CORRIGENDUM

1. This is with reference to Advertisement **No. 002/2017** dated **27.09.2017** advertising various teaching positions.

3. In view of technical problem in the "ONLINE" mode of receipt of applications the University has **decided to call applications by OFFLINE mode ie By Post.** Accordingly following terms and conditions be added / inserted :

- Applicants must apply on prescribed form available on website. Applications in any other form than prescribed form will be rejected. The envelope containing application should be super-scribed as "Application for the post .....".
- Application accompanied with the requisite fee as per following details in form of a non-refundable **demand draft drawn from any nationalized bank in favour of the Finance Officer, Central University of Himachal Pradesh payable at Dharamshala, Himachal Pradesh only:**  
**General Category : Rs500/-**  
**OBC Category : Rs400/-**  
**SC/ST/PWD/Female Candidates: NIL**
- The application duly filled in the prescribed form along with required documents must reach the University on or before **14 NOVEMBER, 2017** at the below given address. Applications received after this date shall not be considered. University will not be responsible for any postal delay.

- The applicants serving in Government / Semi-Government organizations / Public Sector Undertakings / Autonomous Bodies must send their applications **“Through Proper Channel”** after endorsement by the current employer in the place provided in the application form. The applications received without the recommendations of the employer will not be considered. However, an advance copy of application may be sent followed by the original application through proper channel.

- **Call letters for attending Written Examination/Interview will be sent only to the short-listed candidates by Email only.** No correspondence will be made with applicants who have not been short-listed/not called for interview. In case the University receives large number of applications for a particular post, the University in such cases reserves the right to conduct written exam for shortlisting candidates to be called for interview.
- Candidates belonging to SC/ST/OBC category should enclose proper caste certificate with their application as per the proforma of Govt. of India. In the case of OBC candidates, the certificate should among others specifically mention that he/she does not belong to the persons/sections (creamy layer) as mentioned in Col. 3 of the schedule to the Department of Personnel & Training in the Govt. of India OM No. /36012/22/93-Estt. (SCT) dated 8/9/93 at the time of test/interview.
- Reservations for SC, ST, OBC and Persons with Disabilities will be as per Government of India norms as amended from time to time. Candidates applying for the reserved posts should clearly state to which category they belong. They must also enclose Certificate issued by Tahsildar/Mandal Revenue Officer/Equivalent authority as proof to this effect with their application, without which the application will not be considered.

In case a candidate wants to claim benefits under the Persons with Disabilities (PWD) category, the candidate's relevant disability should be not less than 40%. Certificate, to this effect, must be enclosed with application by the candidate issued by the competent authority, without which the application will be treated as 'General (unreserved)' or invalid if post is only one and reserved for PWD.

Candidates applying for the post(s) reserved for OBC, should enclose a self-attested copy of valid caste certificate with application specifically mentioning Creamy Layer-exclusion in the format prescribed by Govt. of India (*which should not be more than 6 months old from the last date of submission of application*), issued by competent authority, vide Column 3 of GOI Dept. of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 8.9.1993 and modified vide DoPT's O.M. No. 36033/3/2004-Estt.(Res) dated 9.3.2004, subsequently revised vide O.M. No.36033/3/2004-Estt.(Res) dated 14.10.2008. The Caste Certificate must be in the format as prescribed by the Govt. of India vide OM No. 36036/2/2013-Estt. (Res.) dated 30/05/2014 at the time of Written Exam / Interview. **There will be no reservation for OBCs in the posts of Associate Professors and Professors.**

- The candidates applying for the post of Professor and Associate Professor must have guided at least one scholar for Ph. D degree successfully.
- The eligibility of candidates will be determined as on the last date fixed for receipt of application forms i.e. **14 Nov, 2017.**
- **Fake Institutions:** Candidates, who have obtained degrees or diplomas or certificates for various courses from any Institution declared fake by the University Grants Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised. In case such cases are noticed after selection during the service of the candidate, his/her services shall be terminated forthwith.

In view of above addition of the General Instructions the following Instructions under General Conditions of the Original Advertisement dated 27.09.2017 be treated as cancelled:
