## Admission to B.Voc Financial and Marketing Services Academic Session 2018-19

The Provisional Selection list of candidates selected for admission to **B.Voc. Financial and Marketing Services** (Academic Session 2018-19) is enclosed herewith. This list has been prepared on the basis of merit of 10+2 marks. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

- l. "The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category."
  - If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of verification of documents and registration.
- 2. The selected candidates have to deposit the admission fee latest by 05<sup>th</sup>July2018 failing which the vacant seats shall be offered to the wait-listed candidates. The Eligible candidates can deposit their fees from 2<sup>nd</sup> July 2018 after 5:00 PM
- 3. Please follow the following steps to remit fees online:
  - i. Go to https://canbankfeecounter.com
  - ii. Click on Student/Parent Login.
  - iii. Select School/College.
  - iv. Enter the Registration Number and password. (Registration number and password are same as your Roll Number.)
  - v. Enter Captcha code.
  - vi. Proceed.
  - vii. Change the password to your convenience if desired.
  - viii. Select "Regular fee" under "Online Fee Payment".
  - ix. Student's Name, Class, Father's name and Fees will be displayed.
  - x. After confirming your credentials click on "Proceed".
  - xi. Click on "Make payment" and "Pay now".
  - xii. You can choose Net banking / Debit card / Credit card to pay.
- 4. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on 1st August 2018 for registration and verification of academic qualifications/documents. He/She must bring the following documents:
  - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
    - i. Marksheets of Matriculation and 10+2 and Graduation.

- ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
- iii. Kashmiri Migrant Certificate, if applicable.
- iv. Persons with Disabilities Certificate, if applicable.
- (b) Original Documents tobe submitted:
  - i. Migration Certificate
  - ii. Character Certificate
  - iii. Self-declaration by student for intervening period/over a gap of three years, if applicable
  - iv. Employer's no objection certificate, if applicable
  - v. Two Passport size photographs.
- 5. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- 6. The registration for courses in a Programme of Study shall be made on 1st August 2018. The regular classes shall commence from 2<sup>nd</sup> August, 2018 itself.
- 7. In case the seats remain vacant in the first round, the second selection list will be displayed/uploaded on University Notice Board/Website on 6<sup>th</sup> July 2018 .
