1. **“The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category.”**

**If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of verification of documents and registration.**

- All students whose names appear in the below list are advised to deposit **Admission Fee** amounting to ₹ 13,300.00 (Rupees **Thirteen Thousand Three Hundred Only**) for the **1<sup>st</sup> semester** in the **“University Bank Account”** latest by **27<sup>th</sup> August, 2018** failing which their admission will be cancelled.
- The selected students have to deposit the admission fee in the University Bank account mentioned below, **preferably from any branch of Canara Bank throughout India** or through NEFT/RTGS from any other bank. 4. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on **24<sup>th</sup> August, 2018 after 02:00 PM** for registration and verification of academic qualifications/documents. He/She must bring the following documents:
  - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
    - i. Marksheets of Matriculation and 10+2 and Graduation.
    - ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
    - iii. Kashmiri Migrant Certificate, if applicable.
    - iv. Persons with Disabilities Certificate, if applicable.
  - (b) Original Documents to be submitted:
    - i. Migration Certificate
    - ii. Character Certificate
    - iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
    - iv. Employer's no objection certificate, if applicable
    - v. Two Passport size photographs.
5. The University offers **limited hostel facility for boys at Kangra and for girls at Dharamshala**. The seats in hostels shall be allotted on the basis of merit as per the reservation policy of the government of India.
