Provisional List of Candidates selected for Admission to **Ph. D. Programme in the Department of Education** (Academic Session 2020-21) is attached herewith. The list has been prepared on the basis of Composite Merit of marks scored in the Entrance Test (with 70% weightage) and Personal Interview (with 30% Weightage). Every care has been taken to prepare the provisional selection list. Mistakes, if any, are inadvertent and subject to rectification. It is also informed to all the prospective selected candidates that course work is mandatory for all candidates and no exemption will be given to any candidate on any ground.

The provisionally selected candidates are hereby directed to submit their following documents to verify their academic qualifications and other claims made by them in their Application Forms.

In this regard, the candidates are directed to scan the following original documents / self-attested photocopies through a quality scanning software and prepare a "SINGLE 'PDF' FILE" of all scanned documents.

6. M. Phil. (Education) Marksheet and / or Degree Certificate (If Applicable)
7. Certificate in respect of UGC-NET / JRF / SLET (in Education) / Himachal Pradesh Kendriya Vishwavidyalaya Shodh Patrata Pariksha (HPKVSP), whichever is applicable.
8. SC / ST / OBC / EWS Category Certificate. (OBC 'Non-Creamy Layer' certificate should have not been issued later than six months and it should be issued as per Rules of Govt. of India. The EWS certificate should have not been issued later than twelve months. If any of these two category certificates is not as per requirements, the candidate will be given a time of fifteen days to prepare and submit a latest one to School of Education, CUHP) through e-mail.
9. Kashmiri Migrant Certificate, if applicable.
10. Persons with Disability Certificate, if applicable.
11. No Objection Certificate (NOC) from the Current Employer, if applicable.
12. Two Latest Passport Size Photographs
13. **UNDERTAKING BY THE CANDIDATE** on plain paper mentioning that the documents being submitted through e-mail are valid and authentic to the best of his/her knowledge and belief. This UNDERTAKING is given at the end of this provisional selection list which the candidates are required to scan after filling it properly and making their signature on it. If a candidate is not in a position to get printout of this UNDERTAKING, he/she may directly send it in the form of e-mail message along with attached PDF file of scanned documents with the e-mail.

The candidates will send the scanned PDF file of all documents including UNDERTAKING to the School of Education, CUHP, Dharamshala on e-mail ([soe.cuhp@gmail.com](mailto:soe.cuhp@gmail.com)). The scanned images should be clearly visible and should reach on or before 18<sup>th</sup> June 2020. If any candidate has any issue in the submission of all or any of the above specified documents, he / she may inform about the same through e-

mail by 17<sup>th</sup> June 2020 for seeking permission for extension of date for submitting documents.

After verification of documents of provisionally selected candidates by the School of Education, the Final Selection List of Candidates will be uploaded on CUHP website. The original documents will also be physically verified by the university when the university will start functioning in a full-fledged manner after removal of restrictions on account of CoVID-19.

The following documents are to be submitted in original by the candidates after their final selection and submission of admission fee:
