- We shall protect the rights and interests of stake holders and the society at large

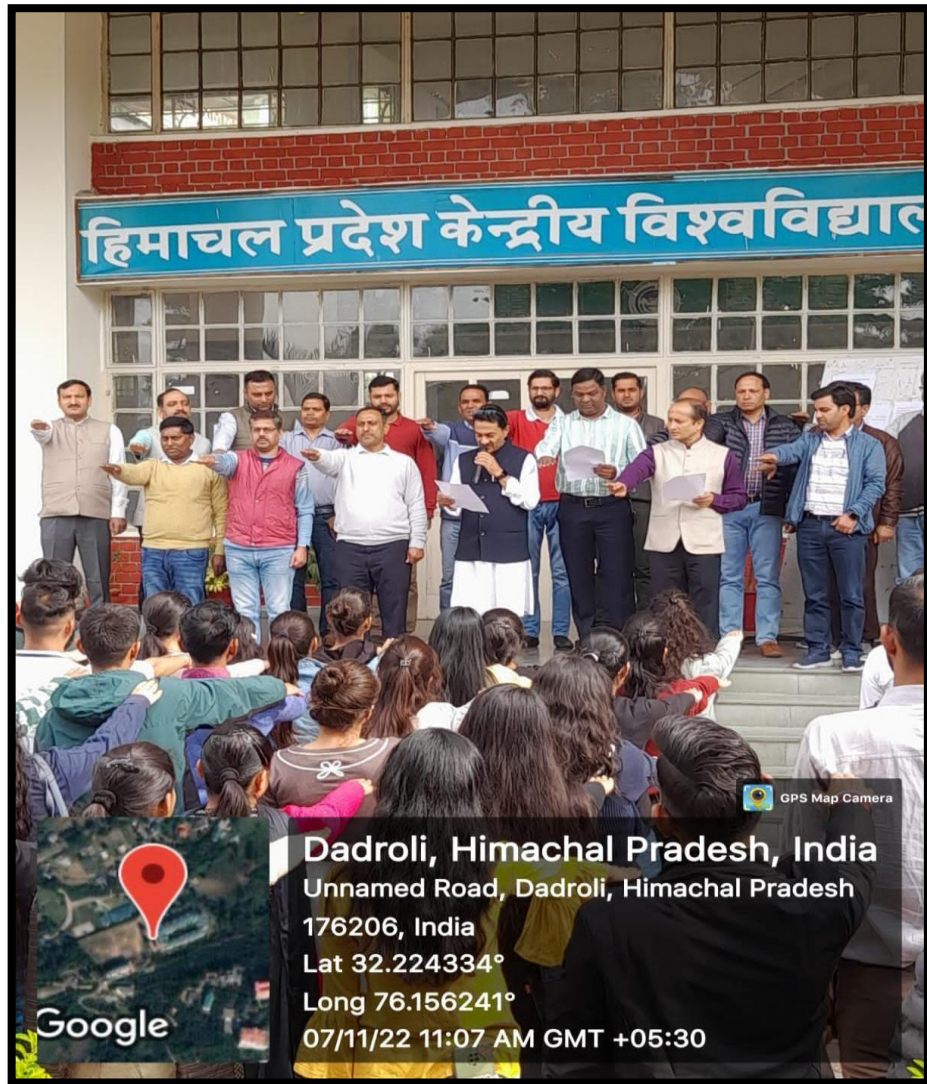

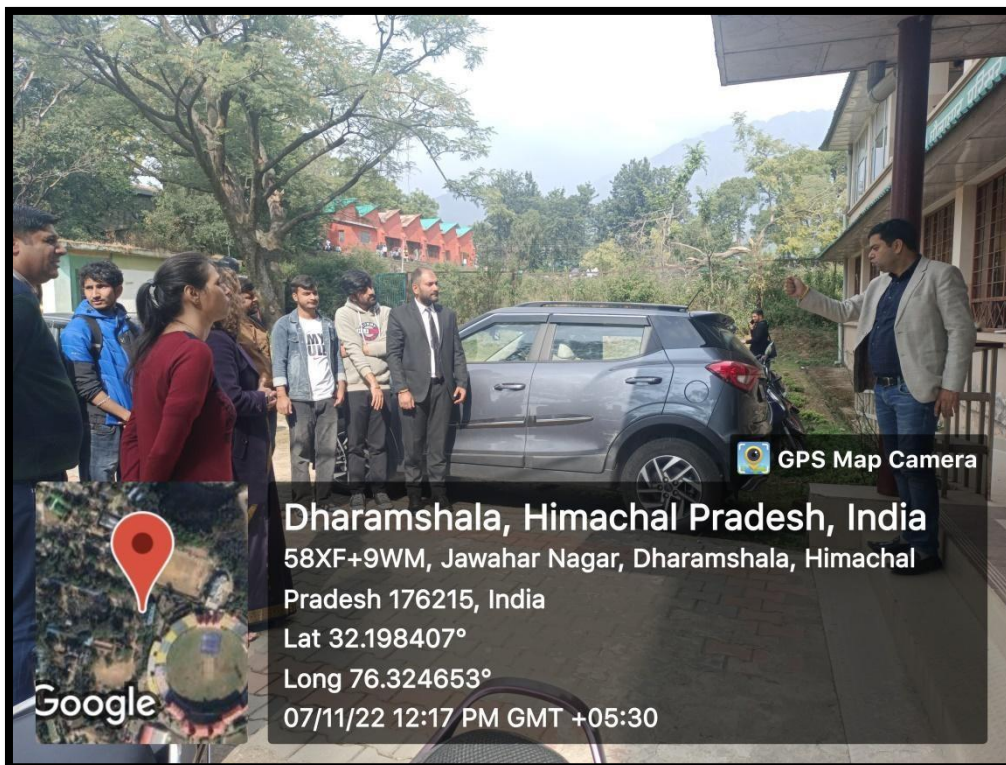


## **Dhauladhar Campus- II**

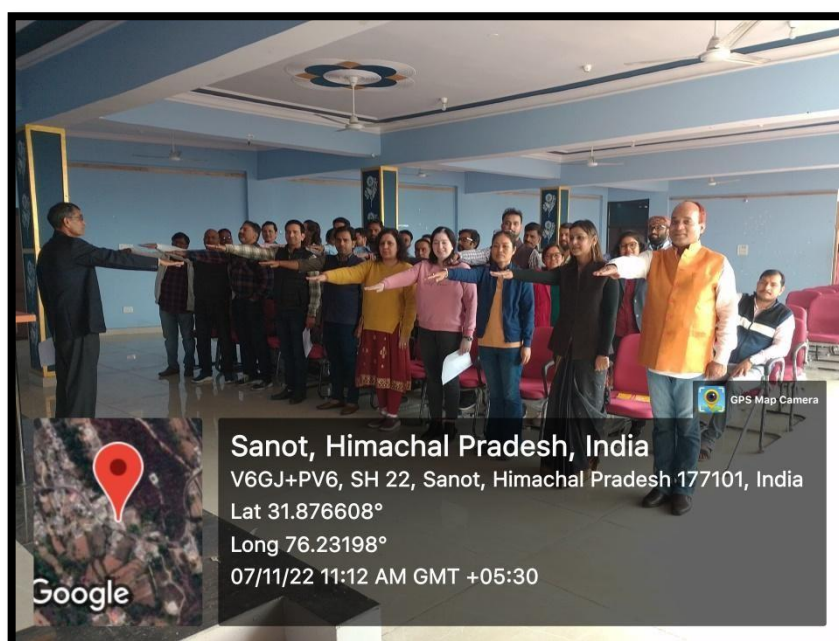




## Dehra Campus
