The Course TTM – Dissertation along with detailed course contents and rules was approved. It was recommended that the course be offered to the students admitted in 2019-20

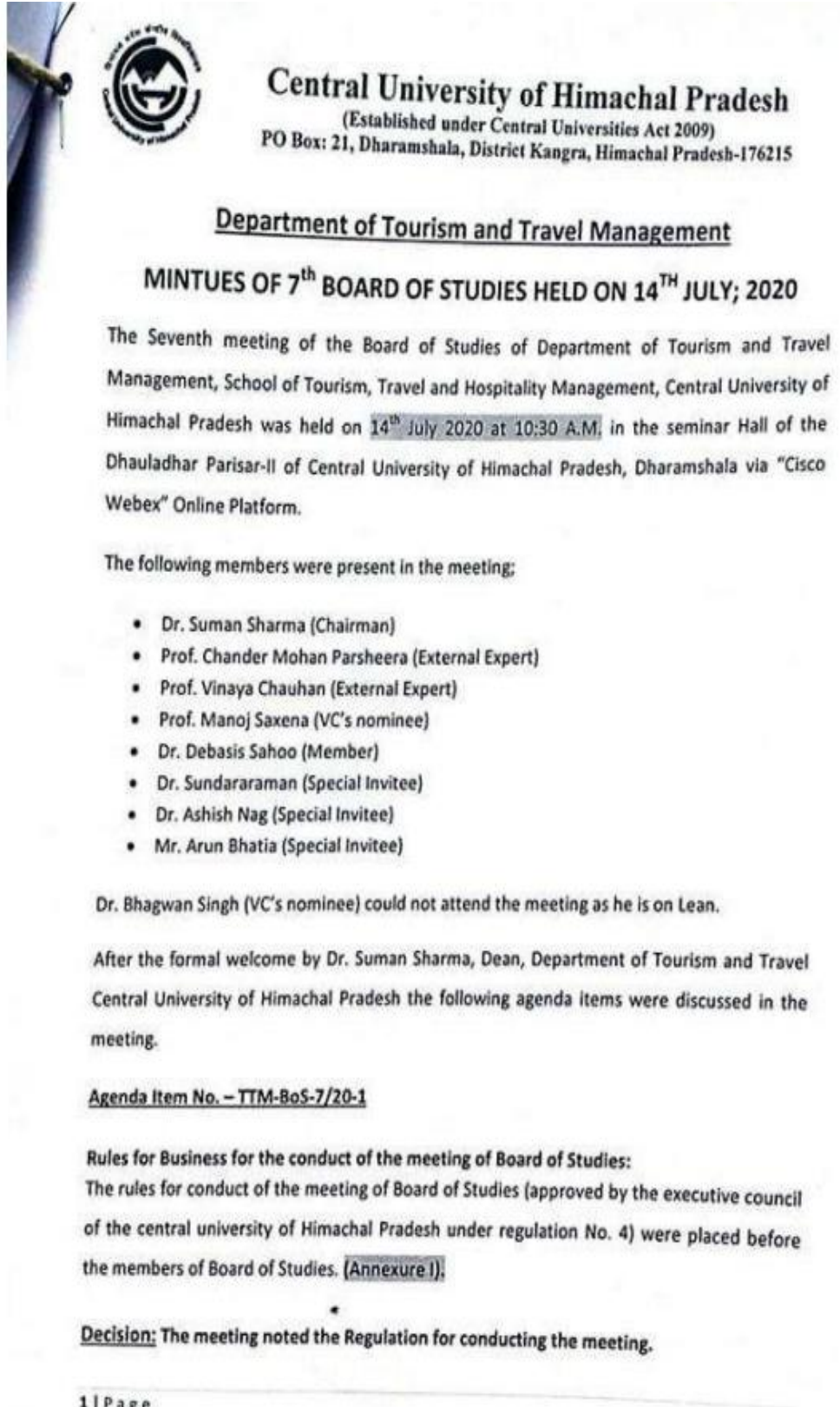
