**MINUTES OF 32ND MEETING OF THE ACADEMIC COUNCIL SCHEDULED TO BE HELD ON
31ST AUGUST, 2022 (BY CIRCULATION)**

Item No. 32.1: To place before the matter regarding misplacement of answer sheets in the Department of Physics.

The matter under reference pertains to Department of Physics wherein one of the faculty namely Dr. Dalip Singh Verma, Associate Professor reported misplacement of Answer sheets of End-Term Examinations (PAS-411A). The matter was placed before the Vice-Chancellor and a Committee consisting of Prof. Bhag Chand Chauhan, Dr. Rajinder Kumar, Associate Professor and Dr. Mahesh Kulharia, Associate Professor was constituted to submit their report and recommendation in the matter. The said committee was notified vide notification No. PMS/1-1/ CUHP/12/676 dated 12.05.2022. The Committee so constituted submitted their report along with recommendations vide letter No. 158 dated 23.05.2022. The recommendations of the committee are annexed as **Annexure-I** and the gist of the same is appended below:-

"1. अंत सेमेस्टर (End Term) Examination का मूल्यांकन विद्यार्थियों द्वारा प्राप्त मध्यवर्ती सेमेस्टर (Mid Term) तथा आन्तरिक मूल्यांकन (Internal assessment) में प्राप्त अंकों के आधार पर किया जा सकता है i.e. End Term Awards = Mid Term Awards + Internal Assessment."

Apart from the above it is also pertinent to mention here with as per approval of the Vice-Chancellor in the matter a Show Cause Notice **Annexure-II** has already been issued to the teacher concerned and the reply of the teacher along with copy of FIR lodged by him as received is placed at **Annexure-III**.

Due to the above matter the result of the End Term Examinations (PAS-411A) is withheld and keeping in view the academic interest and future of the students concerned.

The Academic Council after deliberations approved the recommendations of the committee constituted for the purposes and further keeping in view the larger academic interests and future of the students, recommended to authorise the University to evaluate the End Term Examinations on the basis of marks obtained by the concerned students in Mid Term Examinations and Internal Assessment i.e. End Term Award = Mid Term Award + Internal Assessment as per recommendations of the Committee.
