7. If the upgrade is provided with desirable features, it should be covered at the cost of

earlier product i.e no extra cost. It should be specifically mentioned in the offer.

## POINTS OF CONSIDERATION FOR e-TENDERING

The Registrar, Central University of Himachal Pradesh, Dharamshala, Distt. Kangra(H.P.) invites online item rate bids (e-tenders) under two cover systems on two bid tender basis from OEM (M/s Fortinet Technologies India Pvt. Ltd) or their authorized partners, for the work of **“Renewal and Activation of subscription for Fortigate 600D Next Generation Firewall & Analyzer FAZ 200F”**.

1. In case the last date of submission of bid is extended, the enlistment of Bidders should be valid on the original date of submission of bids)
2. Time period for the CMC is Three years from the date of award of work.
3. Earnest Money **Rs. 90,000/-** can be paid in the form of Demand Draft/ Fixed Deposit (drawn in favour of The Finance Officer, Central University of Himachal Pradesh, payable at Dharamshala) of any Scheduled Bank shall be scanned and uploaded to the e-tendering website within the period of tender submission.

The intending bidder has to fill all the details of Demand Draft/ Fixed Deposit Receipt (bankers name, amount, number and date) against EMD etc.

The amount of EMD can be paid by Demand Draft/ Fixed Deposit Receipt of any Scheduled Bank. Original to be deposited at the time of opening of technical bid.

4. Technical bid shall be opened first on **10.05.2023 at 2:30 PM**. Eligibility related documents shall be evaluated and parties/agencies will be qualified/disqualified by the Competent Authority.
5. The bid submitted shall become invalid if:
  - a. The bidder is found ineligible.
  - b. The bidder does not upload all the documents (including GST registration) as stipulated in the bid document.
  - c. If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the bidder in the office of tender opening authority.
  - d. The bidder does not deposit physical EMD and Tender cost at the time of technical bid opening.
6. The Bidders whose bid is accepted will be required to furnish **performance guarantee of 5% (Five Percent) of the tendered amount** within the period specified in Schedule F. This guarantee shall be in the form of Demand Draft/Fixed Deposit Receipts of any Scheduled Bank in accordance with the prescribed form. In case the **Bidders fails to deposit the said performance guarantee within the period as indicated in Schedule 'F' including the extended period if any, the Earnest Money deposited by the Bidders shall be forfeited automatically without any notice to the Bidders**. 9. Canvassing whether directly or indirectly, in connection with tenderer is strictly prohibited and the tenders submitted by the Bidders who resort to canvassing will be liable to rejection.
10. The competent authority reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.

## Scope of Work and Terms & conditions of Contract

### Scope of Work:

- a. The contract is for a period of three years.
- b. Onsite and Online 24 x 7 Technical Support, Training, Escalation Matrix should be shared for the Fortigate 600D Next Generation Firewall & Analyzer FAZ 200F/ their upgrade if supplied (whichever is applicable) should be provided by the OEM / Partner (Bidder).
- c. Response time for maintenance of items covered under CMC will be 12 hours including holidays.
- d. In the event of service provider unable to attend call or provide service within 12 hours, Central University of Himachal Pradesh reserves the right to get the work done from outside party and in such cases the expenses for the same will be deducted from the amount payable to the service provider by Central University of Himachal Pradesh.
- e. Bidder shall not engage any sub-agent or sub-contractor whatsoever for running the CMC Service.
- f. The contract for running the CMC Service shall be a commercial contract between Central University of Himachal Pradesh and OEM / Partner (Bidder).
- g. The CMC is of Comprehensive type. Any replacement of spares should be with new and of equivalent type or higher of same make, and should be available within 2-3 business working days.
- h. Replacement of the faulty parts etc. shall be done at the OEM's / Partner's own cost for ensuring smooth services.

### Special Conditions of CMC/Renewal:

- a. Details of monthly scheduled maintenance/break down shall be entered in the register/service slip/online service report & jointly signed by the firm's representative and Central University of Himachal Pradesh representative.
- b. Contractor will have to offer onsite visit whenever required during the CMC period. Beside this, any number of breakdown calls will have to be attended. The response time for such breakdown calls shall not exceeds 12 hours. Beyond this penalty shall be imposed as per penalty clause.
- c. OEM's /Partner's trained service support engineer shall reach to the site/online resolution of the ticket/issue reported within 12 hour after lodging a complaint. Delay in reporting period shall be recorded and penalty shall be imposed as per penalty clause.
- d. No parts or components of the firewall being maintained by OEM / Partner shall be removed without prior approval and knowledge of Central University of Himachal Pradesh . Any part to be removed/replaced shall be done after approval of the Honorary Director Computer Centre and same shall be provided within 2-3 business working days.

- e. OEM / Partner shall not only attend the failure but also rectify the cause of failure after investigation.
- f. Penalty imposed for late reporting, late replacement of defective parts and Down time of lift shall be deducted from periodic bills of the firm.
- g. 90% payment shall be released after the successful upgradation /installation, commissioning and satisfying other terms and conditions of the tender document. The remaining payment shall be made after successful completion of contract agreement..

## **Equipment Description:**

### **Contractor to comply with laws:**

- a. In the performance of this Contract, the OEM / Partner shall abide by all existing laws, codes, rules and regulations set forth by all governmental units and authorities having competent jurisdiction over OEM / Partner, and/or the work performed by OEM / Partner hereunder. **Preamble**

WHEREAS the Principal / Owner has floated the Tender ..... (hereinafter referred to as

"**Tender/Bid**") and intends to award, under laid down organizational procedure, contract for **Name of work:-" Renewal and Activation of subscription for Fortigate 600D Next Generation Firewall & Analyzer FAZ 200F."**, Herein after referred to as the "**Contract**"

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Bidders(s). AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "**Integrity Pact**" or "**Pact**"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

**Article 1: Commitment of the Principal/Owner**

- 1) The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - (a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
  - (b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
  - (c) The Principal/Owner shall endeavor to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
- 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance

Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

**Article 2: Commitment of the Bidder(s)/Bidders(s)**

- 1) It is required that each Bidder/Bidders (including their respective officers, employees and agents) adhere to the highest ethical standards and report to the Government / Department all suspected acts of **fraud or corruption or Coercion or Collusion** of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Bidders(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

  - c) The Bidder(s)/Bidders(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - d) The Bidder(s)/Bidders(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Bidders(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
  - e) The Bidder(s)/Bidders(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.

- 5) The Bidder(s)/Bidders(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).



### **Article 3: Consequences of Breach**

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Bidders(s) and the Bidder/ Bidders accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1) If the Bidder(s)/Bidders(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the Bidders shall have powers to disqualify the Bidder(s)/Bidders(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Bidders from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. **Such exclusion may be forever or for a limited period as decided by the Principal/Owner.**
- 2) **Forfeiture of EMD/Performance Guarantee/Security Deposit:** If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Bidders.
- 3) **Criminal Liability:** If the Principal/Owner obtains knowledge of conduct of a Bidder or Bidders, or of an employee or a representative or an associate of a Bidder or Bidders which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

- 2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Bidders as deemed fit by the Principal/ Owner.
- 3) If the Bidder/Bidders can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.
