The **Provisional 2nd Selection list** of candidates selected for **admission** to **PG Diploma in Energy Economics** (Academic Session 2023-24) in the **Department of Economics**, School of Social Sciences, is enclosed herewith. This list has been prepared on the basis of merit in qualifying exams. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

- 1. "<u>The OBC candidates who belong to Non-Creamy layer and whose castes appear in</u> <u>Central list of the OBCs shall be eligible for admission under the OBC category</u>." If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of verification of documents and registration.
- 2. The selected candidates have to **deposit** the admission fee latest by **01 September**, **2023** failing which the vacant seats shall be offered to the wait-listed candidates.
- 3. Total Fee for PG Diploma in Energy Economics: Rs. 2700.00
- 4. Option of Paying the Admission Fee shall remain open from **31 August**, **2023** to **01 September**, **2023**.
- 5. Link to making payment for the admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
- 6. Proof of Confirmation of fee submission received from SAMARTH Portal/payment gateway should be sent to concerned department Email ID: hod_eco@hpcu.ac.in and sharmasubhu13@hpcu.ac.in latest by 02 September, 2023.
- 7. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on **04 September**, **2023** for registration and verification of academic qualifications/documents. He/she must bring the following documents:
 - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - i. Mark sheets of Matriculation, 10+2 and Graduation.
 - ii. Category Certificate, if applicable (OBC certificate should have not been issued later than six months).
 - iii. Kashmiri Migrant Certificate, if applicable.
 - iv. Persons with Disabilities Certificate, if applicable.
 - v. EWS Certificate, if applicable
 - vi. Aadhar Card

- (b) Original Documents to be submitted:
 - i. Migration Certificate
 - ii. Character Certificate
 - iii. Self-declaration by the student for intervening period/ over a gap of three years, if applicable
 - iv. Employer's no objection certificate, if applicable
 - v. Two Passport size photographs.
- 8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information/ qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- 9. The registration for courses in a Programme of Study shall be made on 04 September, 2023. The regular classes shall commence from 04 September, 2023 tentatively. Any change in commencement of classes shall be intimated to all selected candidates through Email/University website.
- 10. If the seats remain vacant after the third round, the details will be uploaded on the University website. Interested candidates are advised to visit the University website/Notice Board regularly for updates.
