1. "The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category."

If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of verification of documents and registration.

- The selected candidates have to deposit the admission fee latest by **15th September 2023** failing which the vacant seats shall be offered to the wait-listed candidates.
- Total Fee for M.Sc. Environment Science: **Rs. 13,850.00**
- Total Fee for M.Sc. Environment Science (Self Finance): Rs. 50,000.00**
- Option of Paying the Admission Fee shall remain open from **14th September, 2023 till 15th September 2023.**

- Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to the department at Email ID: rajeev.singh@hpcu.ac.in .Latest by 15th September, 2023.
- The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on **18th September 2023** for registration and verification of academic qualifications/documents. He/She must bring the following documents:
 - Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - Marksheets of Matriculation and 10+2 and Graduation.
 - Category Certificate if applicable (OBC certificate should have not been issued later than six months).
 - Kashmiri Migrant Certificate, if applicable.

- iv. Persons with Disabilities Certificate, if applicable.
 - v. EWS Certificate, if applicable
- (b) Original Documents to be submitted:
- i. Migration Certificate
 - ii. Character Certificate
 - iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
 - iv. Employer's no objection certificate, if applicable
 - v. Two Passport size photographs.
 - vi. Aadhaar Card

The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
