- 5. Bidder has to submit the bid in two bid format on CPP Portal i.e. Technical Bid comprising of all the documents for Technical Evaluation and Financial Bid on the standard uploaded price bid format.
- 6. The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft /Fixed Deposit Receipts of any Scheduled Bank towards **Tender document and EMD in favour of The Finance Officer**, **CUHP payable at Dharamshala** and other documents as specified in the Tender.
- 7. Those Bidders not registered on the website mentioned above, are required to get registered beforehand.

- 10. Technical bid shall be opened first on 30-11-2023 at 03:00 PM. Eligibility related documents shall be evaluated and parties/agencies will be qualified/disqualified by the Central University of Himachal Pradesh. Financial bids of only the technically qualified bidders shall be opened.
- 11. During Technical Scrutiny of the bids, the technical evaluation committee reserves the right to visit the site/premises to assess its suitability as per Institutional requirements/safety point of view. The building shall be accepted/rejected based on the recommendations of the **Technical Evaluation Committee.**
- 12. CUHP reserves the right to accept any tender or reject any or all the tenders.
