6. The bidder/OEM should submit Average Annual Turnover proof duly certified by the Chartered Accountant for last three F.Y. (2020-21, 2021-22, 2022-23).
7. The bidder/OEM should submit its Manufacturing Plant details i.e. Address, GST certificate. E-way bill must be from the same location during the supply of material.
8. **Sample Inspection:** Bidders may be asked to submit the furniture item samples for approval of the committee during Technical Bid document evaluation stage. Samples shall be submitted within 10 days from the intimation to the prospective bidders.

9. Local content declaration (on bidder company's letterhead as per **Annexure - I**) is mandatory to be provided by the prospective bidders failing which the bid will be treated as non-responsive and will be rejected.
