- "The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category." If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission
- fee. As their admission will be cancelled at time of verification of documents and registration. The selected candidates have to deposit the admission fees within 16th August, 2024 (05:00PM) to 19th August 2024 failing which the vacant seats shall be offered to the wait-listed candidates.
- Total Fee for MA Education: Rs. 5,550/-. 3.
- Fee for Self Financing Seats in MA (Education) is Rs. 50,000/-
- The portal for paying the Admission Fee shall remain open from 16th August, 2024 (05:00PM) to 19th August 2024. 4. 5.
- Link of making payment for the Admission shall be available on the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study were opted. 6.
- Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to 7.
- The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on 23th August, 2024 for registration and verification of academic qualifications/documents. He / She must 8.
