## Admission to M. Sc. Chemistry Academic Session 2024-25

The **Provisional 4<sup>th</sup> Selection list against open call registration** of candidates selected for admission to **M.Sc. Chemistry** (Academic Session 2024-25) is enclosed herewith. This list has been prepared on the basis of merit in qualifying examination. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

- "The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBCcategory."
  If the Candidates selected in OBC category do not belong to Non Creamy layer they must notdeposit the admission fee. As their admission will be cancelled at time of verification ofdocuments and registration.
- 2 The selected candidates have to deposit the admission fee latest by **23 August**, **2024** failing which the vacant seats shall be offered to the wait-listed candidates.
- 3 Total Fee for M.Sc. Chemistry (Self-Financing) : Rs. 50000.00
- 4 Option of Paying the Admission Fee shall remain open from 23 August, 2024 till 11:59 PM.
- 5 Link of making payment for the Admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
- 6 Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to the department at Email ID: <a href="mailto:sureshkumari731@hpcu.ac.in">sureshkumari731@hpcu.ac.in</a> latest by 24 August 2024.
- 7. The admitted candidate must report in person to the Chairman of the Admission Committee of the Department on **27-08-2024**, for registration and verification of academic qualifications/documents. He/She must bring the following documents:
  - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
  - i. Marks sheets of Matriculation and 10+2 and Graduation.
  - ii. Category Certificate if applicable (OBC/ EWS certificate should have not been issued later than 6 months).
  - iii. Kashmiri Migrant Certificate, if applicable.
  - iv. Persons with Disabilities Certificate, if applicable.
  - v. NTA CUET (PG) Score Card.

vi. Aadhaar Card.

- (b) Original Documents to be submitted:
  - i. Migration Certificate
  - ii. Character Certificate
  - iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
  - iv. Employer's no objection certificate, if applicable
  - v. Two Passport size photographs.
- 8 The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- 9 The registration for courses in a Programme of Study shall be made on 27<sup>th</sup> August 2024. The regular classes shall commence from 27<sup>th</sup> August, 2024 tentatively. Any change in commencement of classes shall be intimated to all selected candidates through E-mail/University website.
- 10 In case the seats remain vacant, after the 4<sup>th</sup> selection list, the details will be uploaded on the university website. Interested candidates are advised to visit the university website/notice board regularly for updates.
