The University is funded and regulated by the University Grants Commission (UGC). The University became functional with the assumption of charge by the first Vice Chancellor on 20th January 2010.

Whereas,

SR Asia and CUHP (in Partnership) has decided to actively work for realizing its vision for leveraging Sustainable Development to enable Quality Human Resources towards addressing the huge industry demand for ensuring competitiveness in the present market-driven environment. In light of the Company Act, 2013, it mandates Corporate to spend their 2% Profit after Tax (PAT) for CSR (Corporate Social Responsibility) which to be administered by an independent 'CSR Department' thoroughly backed by Government of India law and norms. In response to this major national development, the parties have had substantially discussed on the above matters and have

ascertained areas of broad consensus, subsequently the college and SR Asia in principle agreed to establish a professional relationship between them. The parties now, have therefore, agreed to enter in writing these areas of consensus, under a Memorandum of Understanding.

The Programme for which this MoU is signed is to be known as "Leveraging CSR and Sustainable Development". Whereas SR Asia is desirous of undertaking a joint project for the training and handholding component of the said scheme with the College. Thus, the two parties to this Memorandum of Understanding, with the intention of both being legally bound, accept the following terms and conditions:

Coordination and Contact Points-

- a. College for development of content, and jointly organize workshops to realize the broad CSR goals of reaching sustainability.
- b. SR Asia for all operational matters which includes provisioning of finances, and project handholding.

Now this Memorandum of Understanding witnesses that:

It is proposed to start the following activities under sustainable development-

1. Series of Training/ capacity building workshops related to CSR, Sustainability and Sustainable Development for the Government, Government Organizations, PSUs, Corporate and NGO Sector. SR Asia and CUHP can jointly initiate workshops on CSR for Schools, Colleges, Young professionals and NGOs. The content can be developed jointly and both organizations can spread the word in their networks.
2. Training on Sustainability Reporting and Assurance Services (AA1000AS)
3. Project implementation
4. Baseline, Need Assessment, EIA (Environment Impact Assessment) and M&E (Monitoring & Evaluation)
5. SR Asia in partnership mode will organize series of National and International Workshops,
6. Management Development Programmes (MDPs) on Sustainability, CSR, Sustainable Development, Corporate Ethics, CSR implementation CSR, Sustainability and Sustainable

7. College will promote SR Asia as the partner for CSR implementation.
8. Any other initiative which would work for strengthening of both the organization's vision and objectives could be taken up based on mutual consent and discussion.

Other Areas of Consensus-

- a) To ensure the Sustainable Growth of Department of Social Work, Central University of Himachal Pradesh and SR Asia.
- b) Communication between the of Department of Social Work, CUHP and SR Asia shall be in Hindi & English
- c) There should be proper linkage of website and logo sharing of College and SR Asia respectively.
- d) The Department of Social Work, CUHP and SR Asia agree to exercise reasonable care to safeguard interest of each other, to maintain confidentiality regarding the Proprietary information and to prevent the unauthorized use or disclosure thereof by them or any other person.
 - Both the Parties can share their data bank (within themselves) for better operations and larger dissemination of information to the beneficiaries in civil society (on above mentioned activities), but shall not share the same to any third party.
 - Any Assignment / Project / Activity / Concept Notes / will not be shared or disclosed until it commences.
 - Materials having Copyright of either party's shall be used and utilized with both parties consent.
 - The ongoing Activities details will exhaustively be shared in both parties respective website with same verbatim and same to be communicated to the service takers at same version. For better results Department of Social Work, CUHP & SR Asia should speak in same line of action.
- e) Any dispute, difference or controversy of whatever nature howsoever arising under, out of or

in relation to this MoU between the parties and so notified in writing by either party to the other, in the first instance, shall be attempted to be resolved amicably by the parties or by the Arbitration and all correspondence in this regard, written and verbal shall be conducted in English language. Any decision or award resulting from same interventions shall be final and binding upon the parties.

Validity of this MoU

The Parties to this MoU agree that it will remain valid till three years i.e July 12, 2026. This MoU may be modified based on a mutual understanding between the Department of Social Work, CUHP and SR Asia. Such understanding shall always be in writing, signed by both the Parties.

Termination Clause: The MoU can be terminated in mutual agreement with 3 months prior notice in advance from either side provided there is no joint project in progress.

Renewal of MoU

This MoU may be renewed at the appropriate time before the expiry of its validity period as stipulated, if so decided by the Parties to this MoU, on such terms as will be mutually agreed upon by the said Parties.

Joint Holding of /Workshop/Training/Symposia, etc

Joint organization of workshops/ symposia/ training/lectures etc to improve the exchange of knowledge and experience.

Academic collaboration

Institutions shall collaborate in common thrust areas and internship of students. They shall also be working together in the areas of Course development.

Finances:

As per mutual agreed terms and conditions (2% royalty to the college for each and every project jointly

taken and 8% Development fund to the College after deducting all the expenses.)

Financials for all joint projects will follow national guidelines for financial and account management. For all the joint project each party will commit its time and resources and accordingly financials will be decided on case-to-case basis– No Financial liability

This MoU constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all previous proposals, both oral and written negotiations, representations, commitments, writing and all other communications between the Parties if not released, discharged, changed or modified except by an instrument in writing signed by duly authorized representatives of each of the Parties.


