



**MEMORANDUM OF UNDERSTANDING**

**BETWEEN**

**FORTIS HOSPITAL KANGRA, HIMACHAL PRADESH**

**AND**

**CENTRAL UNIVERSITY OF HIMACHAL PRADESH (CUHP)**

This Memorandum of Understanding ("MOU") made at Dharamshala, District Kangra (H.P.) on this 01<sup>st</sup> day of September, 2023 between the **Central University of Himachal Pradesh**, VC Secretariat, near HPCSA Cricket Stadium, Dharmshala, Tehsil Dharamshala, District Kangra (H.P.)-176215 through its Registrar (hereinafter referred to as the University which expression shall, unless it be repugnant to the subject or context thereof, be deemed to mean and include its successors and permitted assigns) of the **FIRST PART**;

AND


The Fortis Hospital Kangra (A unit of Himachal Healthcare Private Limited) is a tertiary healthcare hospital situated at Kangra (Dharamshala Road), District Kangra H.P. having its Registered Office at Near Mazdoor Kutir Rahelpura, Kangra H.P.-176001 through its Facility Director, Dr. Aman Samuel Solomon, Fortis Hospital Kangra, District Kangra H.P. (hereinafter referred to as the "Fortis Hospital Kangra" which expression shall, unless it be repugnant to the subject or context thereof, be deemed to mean and include its successors and assigns) of the **OTHER PART**;

1. **DEFINITIONS:** In this MoU the following terms & conditions shall be interpreted as indicated:

- (1.1) "Memorandum of Understanding" means an agreement entered into between Central University of Himachal Pradesh and Fortis Hospital Kangra, as recorded in the agreement / document signed by the parties.
- (1.2) "University" means Central University of Himachal Pradesh, (Dharamshala) VC Secretariat, near HPCA Cricket Stadium, Dharamshala, District Kangra H.P.-176215.
- (1.3) "Fortis Hospital" means Fortis Hospital Kangra having its Registered Office at Near Mazdoor Kutir Rahelpura, Kangra H.P.-176001 .
- (1.4) "Services" means the medical facilities to be provided by the Fortis Hospital Kangra according to the following terms and conditions.

2. **TERM:**

This MOU shall be effective from 1<sup>st</sup> September, 2023 to 31<sup>st</sup> August, 2028.



## Terms & Conditions:

### 3. CGHS Rates:

The Hospital will charge CGHS 2014 Chandigarh Nabh rates for IPD/OPD. In case the hospital tariff is lower than CGHS, then the lower tariff shall be applicable. These rates shall be applicable to the employees, their dependents and retirees of Central University of Himachal Pradesh. Any changes in CGHS rates for OPD/IPD shall be applicable from time to time.

#### a). Service Taxes:

The Goods & Service tax shall be charged separately as applicable.

#### b). The applicability:

The applicability of the association (MoU/Contract) shall be for a period of 05(five) years from the date of entering into an association and shall stand extended for a further period of 1(one) year on each occasion if no party gives notice of non-renewal, 30 days prior to the expiry of the agreement. The agreement can be terminated by one months' notice by either party.

#### c). The employees:

In order to take services shall prove their identity at the time of taking the medical facilities/ services at OPD/IPD.

#### d). Preventive Health Check:

A discount of 15% shall be imparted on Preventive health check programs on Cash Payments.


#### e). Payments:


All OPD bills shall be cleared on cash basis by the employee/patient itself & IPD bills less than 1.0 lakhs shall be cleared on cash basis by the employee itself & more than 1.0 lakhs IPD bills will be settled on the credit

basis. The credit period shall be 15 days and credit shall be in the name of employee/patient. The CGHS payments on account of IPD shall be released to the Fortis Hospital, Kangra through employee concerned on submission of bills duly verified by concerned Medical Officer of Fortis Hospital. In this regard, the Fortis Hospital shall provide all the relevant bills vouchers etc. duly verified & signed by the Medical Officer at the time of discharge of employee/patient. The employee/patient shall be responsible to submit the relevant bills vouchers etc. complete in all aspects to the University within 02 days from the date of discharge from the Fortis Hospital for reimbursement. It shall be entire responsibility of concerned employee/patient to submit entire bill payment to Fortis Hospital within 15 days of discharge from Hospital.

IN WITNESS WHEREOF the Parties hereto have carefully gone through the contents of the Memorandum of Understanding (MoU) and have signed and put their seals on the aforesaid MoU and agreed to abide by the terms & conditions as laid down therein in totally have signed this MoU as of the day and year first above written.



