### A Brief Note

Central University of Himachal Pradesh, Dharamshala entered into a Memorandum of Understanding (MoU) with the Principal, Himachal Pradesh Police Training College, Daroh on 26 day of August, 2022 at Central University of Himachal Pradesh Dharamshala with a purpose to set up an institutional mechanism for interaction between University students/researchers/faculty members and the faculty members/trainees of the Himachal Pradesh Police Training College. The MoU shall be used to help the police personnel to update their knowledge on various relevant subjects. The students and the researchers shall be offered exposure to police functioning and training.

The collaboration shall be based on research and development activities and training which will not only involve students, researchers and Police Officers but also the faculty members and other staff. The collaboration involves research activities for students, researchers and faculty members and training for police officers.

The document was jointly signed by Vice Chancellor, Central University of Himachal Pradesh, Dharamshala and Principal, Himachal Pradesh Police Training College, Daroh.

## Memorandum of Understanding

AND

**Central University of Himachal Pradesh (SECOND PARTY)**

### I. PURPOSE

The purpose of this Memorandum of Understanding (MoU) is:

1. To facilitate and ensure interaction of faculty members and students of Central University of Himachal Pradesh with faculty members and trainees of Himachal Pradesh Police Training College.
2. To help the faculty members and police trainees of basic/promotional/short term courses to update their knowledge on various matters.

### II. OBJECTIVES

This partnership aims to undertake mutually beneficial research and analysis and conduct training & capacity building programs to meet the missions of Himachal Pradesh Police Training College (HPPTC) and Central University of Himachal Pradesh (CUHP). The objectives of the MoU *inter alia* include:

1. To set up an institutional mechanism for interaction of students, researchers and faculty members of CUHP with the HPPTC.
2. Collaboration shall be based on research and development activities and training which shall involve students, researchers, police officers/trainees and faculty members.
3. The collaboration involves research activities for students and faculties and training for State Police.
4. The collaboration involves interaction of students and researchers with police officers to enhance learning.
5. CUHP shall give periodic recommendations for improvement in police working and training at HPPTC.
6. HPPTC shall recognise and facilitate CUHP faculty interests in publishing research papers and conducting specific projects subject to confidentiality of data and police practices.
7. CUHP shall identify key research areas and issues for which CUHP faculty members could conduct research and provide regular feedback and training to HP Police.

### III. TERMS OF AGREEMENT

1. To facilitate and ensure interaction of students and researchers of CUHP with police officers/trainees.
2. The institutional mechanism to include the Vice-Chancellor of the CUHP and one more member nominated by the Vice-Chancellor as member from academia.
3. The Principal, HPPTC will be a part of the institutional mechanism. The SP, HPPTC may be appointed as the nodal officer and member from HPPTC.
4. The CUHP shall send the students, researchers of relevant academic session for short term (ranging from one week to one month) internship to the HPPTC.
5. At the end of internship, the students, researchers shall submit report to HPPTC and CUHP. The CUHP may grade the internship of the students as part of their internal evaluation/assessment process.
6. On specific requests the HPPTC may also organize visit of the students to the HPPTC campus during the internship period.
7. Regular academic conferences/ workshops/ discussions to be conducted by HPPTC and CUHP on various relevant topics.
8. The CUHP shall assist in designing curriculum, delivery and review mechanism for training of police officers on relevant matters.
9. The CUHP shall periodically guide police training, with emphasis on public dealing, behaviour, soft skills, etc.
10. The CUHP shall follow HP Police Policy on confidentiality and privacy of information.



*This MoU does not supersede any existing agreement or arrangement or affect any future agreement or arrangement among the parties and does not affect the ability of the parties to enter into other agreement or arrangement related to this MoU.*

*In the course of agreement under this MoU, it may be necessary for the parties to disclose confidential information. Unless otherwise expressly permitted under any law or by this MoU, any such information shall be kept confidential and not communicated to a third party.*

## VI. DURATION OF MoU AND COMMUNICATION

This MoU shall become effective on the date of signature of all the parties and shall continue for three years and shall also continue to remain in operation beyond that time unless terminated by either Party. It may be amended by mutual agreement of both the parties in writing. It may be terminated by either party without penalty or liability on three months' notice to the other party but not before the completion of the on-going projects.

All communications must be sent to addresses set forth below or to such other addresses designated by both Parties by written notice.

## VII. REGULATIONS


The MoU is non-binding agreement that both Parties have entered into good faith with no financial liabilities.

If any doubt arises as to the interpretation of the provision of this agreement or as to matters not provided therein, parties to this MoU shall resolve such issues after consultation and in good faith.


