The sealed envelope containing quotation shall be superscribed with the **Name of Work, NIQ Ref. No. & Date** and shall reach the O/o Chairman Committee, CUHP, Shahpur, Distt. Kangra, H.P - 176215 by registered post or delivered personally latest by 07.04.2025 upto 03:00 P.M. NIQs received will be opened by committee in the presence of the bidders in the Finance Office at Dharamshala on 08.04.2025, at 11.30 AM.

The processing fee (non-refundable) of Rs.1100/-should be paid towards the cost of NIQ document in the form of A/c payee Bank Demand Draft in the favor of "The Finance Officer, Central University of Himachal Pradesh" payable at Dharamshala and Earnest Money Deposit of Rs 20,000/- (Rupees Twenty Thousand Only) in the form of Fixed Deposit Receipt (FDR) pledged in favour of The Finance Officer, Central University of Himachal Pradesh payable at Dharamshala has to be submitted along with the NIQ and EMD of unsuccessful bidders will be returned to them after expiry of the final bid validity and latest on or before the 30<sup>th</sup> day after the award of the sale letter.

# **Terms & Conditions**

- 1. The Items shall be sold to the H1 Quotationer i.e the bidder that offers Highest Price.
- 2. The bidder should possess a registration as a firm under Proprietorship / Partnership or afirm, with any Government Authority. (Certificate issued by Shops and Establishment registration or Service Tax (GST) Registration or any other issuing Authority).
- 3. In case of a sale involving inter-state movement of goods, the buyer shall also submit an NOC from the concerned SPCB ,with whom the buyer is registered, to the seller before taking delivery, failing which the buyer will be only responsible for the consequences and the seller shall take further decision as may be deemed fit. <u>Agencies without having valid registration and authorization will be not allowed to participate in the bid</u>.
- 4. The bid shall remain valid for **Ninety Days** (90 days) after the date of bid opening. If any bidder withdraws his/her tender before the said period shall prejudice to any other right or remedy, be at liberty to forfeit the EMD absolutely.
- 5. The items offered for disposals are on "AS-IS-WHERE-IS" basis in unpacked condition. The material has to be lifted within **Twenty days** (**20 days**) working days from the date of receipt of the sale letter after making full and final payment to the CUHP .In case the material is not lifted within the time specified ground rent of **Rs 1000/- per day** will be charged from the bidder. The material mentioned in the NIQ is approximate and can be increased and decreased. The tenders should lift the available quantity only.
- 6. The bidders may inspect the items during the office hours and satisfy themselves about the items they are bidding for, as the items condition is on "As-Is-Where-Is 'basis.
- 7. Taxes and duties that may be levied by the Govt. will be extra as applicable and shall be borne and deposited by the highest successful bidder before lifting of the material. GST as applicable will have to be deposited by the highest bidder over and above the bid amount before lifting the material.
- 8. The purchaser may inspect the material before submitting the NIQ during the office hours and no complaint what so ever will been entertained after the NIQ are submitted or before or after materials are lifted. No request for samples or inspection after submission of the NIQ will be accepted.
- 9. Bidders should clearly quote <u>their rates for items enlisted in the Annexure B</u> as asked for both in figures and in words inclusive of all taxes and duties. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the NIQ. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
- 10. The materials will be allowed to be lifted between 11:00 am to 04.00 pm on any working days. <u>No lifting</u> and cutting of material will be allowed on holiday/Saturday/Sunday in any circumstance. Labour, transport and other arrangements will have to be made by the purchaser at the risk, cost and responsibility. No items, once disposed of to the successful bidder, shall be taken back by the University.
- 11. Lot includes batteries therefore disposal of which extant guidelines of Ministry of Environment & Forest is to be adhered to and per the battery (Management and handling) rules. Prospective bidders of such lots of scrap battery should be in possession of registration valid on the date of delivery, as E-waste producer/dismantler/recyclers/refurbisher/collection centres and provide all documents evidence along with signed NIQ documents.

- 12. The successful bidder shall pay full sale value of the contract within Seven days (07 days) from the date of issue of Sale Order/Letter by way of Demand Draft in favor of "The Finance Officer, Central University of Himachal Pradesh" payable at Dharamshala Distt Kangra-176215.
- 13. Consolidated total price should be quoted in the prescribed format under ANNEXURE-B. Please follow the Checklist under Annexure-C for submitting the bids.
- 14. The firm/contractor shall be responsible for the faithful compliance of the terms and conditions enunciated in this document.
