2. Fee for Master of Commerce (M. Com) Rs. 5,550 (First Semester).

3. The option of paying the Admission Fee shall remain open from 1st August to 3rd August, 2025 at 5:00 PM.

4. The link for making payment for the admission shall be available in the Dashboard of each Applicant. This

Dashboard is the same as the one where Registration and specific Programmes of Study were opted.

5. The verification of the Documents of the admitted candidates will be done on 07th August, 2025 at Dhauladhar Parisar-II (in the premises of G.S.S. School (Boys), CUHP, Dharamshala, Kangra, HP, 176215 for registration and verification of academic qualifications/documents. He/she must provide the following documents:

(a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to

be submitted:

i. Mark sheets of Matriculation, 10+2, and Graduation.

ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).

iii. Kashmiri Migrant Certificate, if applicable.

iv. Persons with Disabilities Certificate, if applicable.

v. EWS Certificate, if applicable

vi. Employer's no-objection certificate, if applicable

vii. Two passport-size photographs

viii. Aadhaar Card

- 6. The admission shall be strictly provisional, subject to the verification of Academic qualifications and documents at the time of registration. It shall be cancelled in case of submission of false information/qualifications by the candidate. In that case, the fees deposited by the candidate may not be refunded, and the whole responsibility shall lie on him/her.
