3. Total Admission Fee (Including 1<sup>st</sup> semester) for MBA Travel & Tourism Management : **Rs. 13,850/-**
4. Link of making payment for the Admission shall be available in the **Dashboard** of each Applicant (Samarth Portal). This Dashboard is the same from where Registration and specific Programmes of Study was opted.
5. **Proof of Confirmation** of fee submission received from SAMARTH Portal / payment gateway should be send to concerned department Email ID: **anujsharma57801@hpcu.ac.in**
6. The admitted candidate must **report in person** to the Chairman of the Admission Committee of the concerned Department/School on **26.08.2025** for verification of academic qualifications/documents.

**He/She must bring the following documents:**

**(a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:**

- i. Mark sheets of Matriculation, 10+2 and Graduation.
- ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
- iii. Kashmiri Migrant Certificate, if applicable.
- iv. Persons with Disabilities (PwD) Certificate, if applicable.
- v. EWS Certificate, if applicable
- vi. Application form

**(b) Original Documents to be submitted: (if failed to submit admission would be cancelled)**

- i. Migration Certificate
- ii. Character Certificate
- iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
- iv. Employer's no objection certificate, if applicable
- v. Two Passport size photographs.
- vi. Aadhaar Card
- vii. Fees Receipt

The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.**
