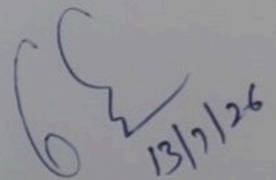
The Provisional Second Selection list of candidates selected for admission to the **Master of Laws (LL.M.)** for the Academic Session (2026-27) is enclosed herewith. This list has been prepared on the basis of merit in **BACHELOR OF LAWS (LL.B. (Three-Year) OR BALLB/BCOMLLB/BBALLB (Five-Year integrated Programme)**. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

1. The OBC candidates who belong to Non Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category.
If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee else their admission will be cancelled at time of verification of documents and registration.
2. The selected candidates have to deposit the admission & payment of fee latest by **15th July, 2026 (5.00 PM)** failing which the vacant seats shall be offered to the wait-listed candidates.
3. Fee for **Master of Laws (LL.M.) First Semester**, for subsidized seats is Rs. 34100/- & for Self-Financed seats is Rs. 49100/-.
4. Option of Paying the Admission & payment of fee shall remain open from **13th July to 15th July, 2026. (5:00 P.M.)**. Link of making payment for the Admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
5. Verification of Documents of the admitted candidates will be done on **20th July, 2026** after the completion of admission process at **Dhauladhar Parisar-I, CUHP, Dhatamshala, Kangra, HP, 176215**. For verification of academic qualifications/documents, the candidate must provide the following documents:

(a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:

- i. Mark sheets of Matriculation, 10+2 and DMC & Degree of BACHELOR OF LAWS (Five-Year integrated (BALLB/BCOMLLB/BBALLB) Programme or Three Year LL.B).
- ii. Migration Certificate in original
- iii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
- iv. Kashmiri Migrant Certificate, if applicable.
- v. Persons with Disabilities Certificate, if applicable.
- vi. EWS Certificate, if applicable
- vii. Employer's no objection certificate, if applicable
- viii. Two Passport size photographs
- ix. Aadhaar Card photocopy.

6. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
7. The registration for courses in a Programme of Study shall be made after document verification and the same will be intimated to all selected candidates through E-mail/University website.
8. In case the seats remain vacant, the **Next Provisional Selection List** from the provisional waiting list will be displayed/uploaded on the University Notice Board/Website on **17/07/2026**.

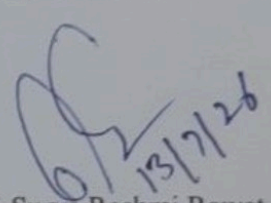
