This list has been prepared on the basis of merit in CUET(PG) Marks by giving first preference and if seats remain vacant then on the basis of merit in UG Marks. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

1. The selected candidates have to deposit the admission fee latest by **25th July, 2026 (5.00 PM)** failing which the vacant seats shall be offered to the wait-listed candidates.
2. Fee for **Master of Commerce (M.Com.)Rs. 5,550 (First Semester)**
3. Option of Paying the Admission Fee shall remain open from **July, 23rd-25th, 2026** Link of making payment for the Admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
4. The verification of the Documents of the admitted candidates will be done on July 27th, 2026 at **Dhauladhar Parisar-II (in the premises of G.S.S. School (Boys), CUHP, Dharamshala, Kangra, HP, 176215** for registration and verification of academic qualifications/documents. He/She must provide the following documents:
 - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - i. Mark sheets of Matriculation and 10+2 and Graduation.
 - ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
 - iii. Kashmiri Migrant Certificate, if applicable.
 - iv. Persons with Disabilities Certificate, if applicable.
 - v. EWS Certificate, if applicable
 - vi. Employer's no objection certificate, if applicable

vii. Two Passport size photographs

viii. Aadhaar Card

5. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
6. The registration for courses in a Programme of Study shall be made after document verification and the same will be intimated to all selected candidates through E-mail/University website.
