The candidate was also unable to answer the questions related to the research proposal, its significant aspects, and general research methodology in Social Work asked by the committee members. Hence, the committee members unanimously did not consider the candidate suitable for admission to the PhD in Social Work programme and decided not to select the candidate for admission to the Ph.D. in Social Work programme for the academic session **2026-27**
