Following decision were taken in the Meeting -

1. **HPKVBS-DSC-12/24-1**

Upon the request received by the supervisor Prof. Sanjeev Gupta regarding his research scholar Rishav Chauhan as per

*“Table Agenda 1: Mr Rishav Chauhan (CUHP20RDMGMT16) was enrolled under the supervision of Prof Sanjeev Gupta. The student has not submitted fees for the past two years and not submitted his progress reports more than three times.”*

And the decision taken by the DSC (HPKVBS-DSC-11/24-9 (I))

*“as the DSC members approved the request of the supervisor as per the provision given in Ordinance 42 Point 16.1 the matter regarding the discontinuation of Ph.D. program.”*

The supervisor has commented in the minutes of 11<sup>th</sup> DSC to reconsider the decision of the 11<sup>th</sup> DSC meeting and bring it for discussion in next DSC meeting.

The matter is presented before the DSC for reconsideration and decision.

**Decision:** After going through all the facts the DSC recommended that the request for Ph D continuation (to deposit balance fee and penalty) of Mr Rishav to be sent to the HVC for necessary approval.

2. **HPKVBS-DSC-12/24/Table Agenda 1**

**Table Agenda:** To place before the DSC the request of Dr Devesh Kumar, Associate Professor to act as a co-supervisor of Ph. D students outside CUHP. Dr Devesh Kumar reported that <sup>before</sup> ~~after~~ he left Shoolini University in 2023 he was guiding two Ph. D scholar. He made a verbal request then to allow him to continue guiding these students. However, the university allocated both these students to new supervisor. However, after one and a half years the Shoolini University sent a letter to Dr Devesh kumar stating to act as co-
