The Head of Department, HPKV Business School, reported to the DSC that Mr. Ravi Kumar, RD Student, enrollment no. CUHP15RDMGMT06 under the supervision of Dr. Rita Devi has requested for extension of Ph. D program. However, the supervisor has reported unsatisfactory performance of the student twice as there is no significant progress in his research work. Mr. Ravi Kumar has already completed eight years in his Ph.D with no satisfactory performance to his supervisor. He has also not submitted his six monthly progress reports, as well as has not appeared before the DRCs and he has also not deposited his fees.

Decision: The Departmental Standing Committee, HPKV Business School considered the matter and deliberated as per the CUHP Ordinance no. 42, As the matter was placed before the DSC and it was

suggested by the DSC that the registration of Mr. Ravi Kumar may be cancelled as he has already completed eight years in his Ph.D with no satisfactory performance to his supervisor. He has also not submitted his six monthly progress reports, as well as has not appeared before the DRCs and he has also not deposited his fees. Therefore, keeping in view the long-term behavior and non-satisfactory research work, the department will give him in writing about the cancellation of his registration.

Agenda Item: Registration cancellation request of Mr. Vikrant Singh Chaudhary, Enrolment no. CUHP17RDMGMT07

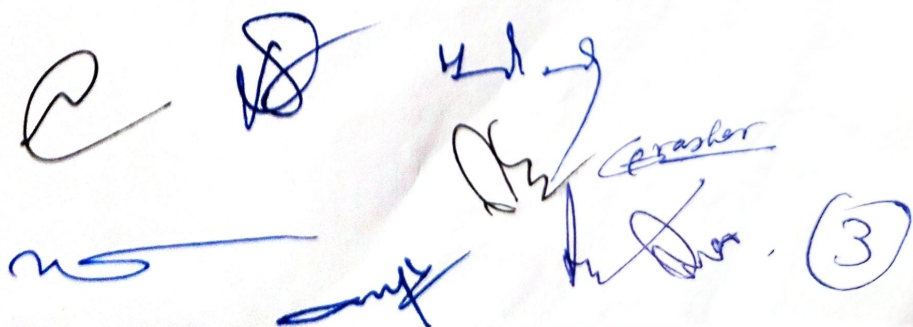
Agenda Item: Request of Ms. Sapna Devi, enrollment no. CUHP21RDMGMT11 to change her Ph.D supervisor

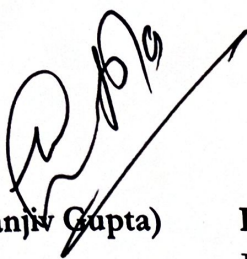

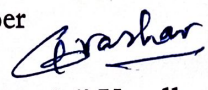

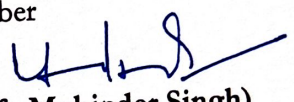
