Decision taken in the meeting:-

All the members of BOS participated in the discussion on each of the agenda items and finally following decision were taken by the members unanimously as per the details given below.

HIS-BoS-7/2021-1:- Confirmation of the minutes of 6th BOS meeting.

Discussion:- The members discussed the content of the minutes of the 6th BoS meeting circulated by the Chairman.

Decision:- The members of the BOS considered the minutes of the 6th BOS meeting and confirmed/approved the draft of the minutes of the 6th BOS meeting unanimously.

HIS-BoS-7/2021-2:- Consideration and approval of the draft of revised M.A. History syllabus in the light of the implementation of New Education Policy (NEP) - 2020.

Discussion:- The members of the BOS discussed the draft of the revised MA History syllabus developed by the Department and codes of courses in the light of the implementation of New Education Policy – 2020 and examined content of all the courses and also raised queries.

Decision:- The members of the 7th BOS meeting unanimously granted approval to the draft of the revised M.A History syllabus/ courses and the codes series from semester I to IV to be implementation w.e.f. 2021-22 academic session.

HIS-BoS-7/2021-3:- Consideration and approval of Value Added Course after discussion on the draft of the Value Added Course presented by the HOD.

Discussion:- The members of the 7th BOS meeting examined and discussed the courses offered in the Value Added Certificate Course named as "Indian Culture and Heritage" for the award of Certificate. The members found this Value Added Course Vible and useful.

Decision:- After the thorough discussion the members approved the draft syllabus of Value Added Certificate Course entitled "Indian Culture and Heritage" to be offered by the Department of History from the academic session 2021-22 along with the content of courses.

HIS-BoS-7/2021-4:- Report to BOS on course on IKS to be developed by the University.

Discussion:- The Chairman reported to the BOS members that in M.A, History 1st Semester a course on IKS for 02 credit will be developed and designed by a committee which is going to appointed by the Hon'ble Vice Chancellor, CUHP. The Chairman sought approval and permission from the BOS members to implement this course. The content of this course will be placed before the Hon'ble members of the BOS in the next BOS meeting for approval.

Decision:- The members discussed the relevance of course on IKS carrying 02 credit and granted approval and permission for adopting this course in M.A. 1st Semester. The members gave direction that the content of this course must be placed before the next meeting of BOS for approval and ratification.
