The National Human Rights Commission sponsors research projects as per the provision under Section 12 of Chapter-III of the Protection of Human Rights Act, 1993

which mandates the Commission to undertake and promote research in the field of human Towards fulfillment of this obligation and mandate, the Commission is sponsoring a

research project titled "Food and Nutritional Security among Scheduled Castes and Scheduled Tribes: Evidence from three Indian States" to Central University of Himachal Pradesh with Dr. Amit Kumar Basantaray, Assistant Professor as Principal Investigator and Dr.Indervir Singh, Assistant Professor as Co-Investigator of the research

The Terms of Reference (ToR) of sanction of the said research project are as under:

- 1.1. To measure the extent of food and nutritional insecurity in the selected states 1. Objectives and Scope of the Study 1.2. To document the differences in food and nutritional insecurity status of SC & ST
 - households and general category households
 - 1.3. To find out the determinants of food insecurity
 - 1.4. To analyse the factors determining nutritional insecurity **1.5.** To examine the problems and challenges with the current programmes in place to
 - - check food and nutritional insecurity
 - 1.6. To provide policy suggestions to eradicate food and nutritional insecurity

2. Locale of Study and Sample Size

- 2.1. Locale: The study will be based on the primary survey that would be conducted in three states namely Odisha, Rajasthan, and Himachal Pradesh.
- 2.2. Sample Size and Sampling Procedure
 - A sample of 1000 households, 400 households each from Odisha and i. Rajasthan and 200 from Himachal Pradesh will be selected for the survey.
 - The study shall use multistage sampling where the selection of district shall ii. be done using development indicators and the selection of tehsil/block shall be based on SC/ST population share. Villages and households shall be selected randomly.

3. Tools and Method for Data Collection

- Extent of food insecurity would be measured by using Food Insecurity i. Experience (FIES) Scale. This FIES can get household level food insecurity as well as intra- household food insecurity. Eight questions of FIES would be asked to each adults of a household to get intra-household food insecurity.
- ii. Second method to be used in the study to cross check the food insecurity status through FIES of households will be the incorporation of appropriate questions.
- Two types of board would be used in the study. Measurement of weight will iii. be done through an electronic weighing scale. All these instruments would be ordered from United Nations which is supplying these instruments specifically to measure correct anthropometric information.
- Field investigators would be trained properly by principal investigator so that iv. they learn the correct measurement techniques.

4. Duration of Project

4.1. The total duration of the Research Project including submission of the final report is 12 months from the date of release of first installment.

5. Financial Assistance

5.1. The project is sanctioned with a budget of Rs 10, 69,625/- (Rupees Ten Lakhs Sixty-Nine Thousand Six Hundred and Twenty Five). The head-wise details are as under-

6. Procedure for Release of installment

6.1. A separate bank account solely for the purpose of the research project has to be opened in any Bank which is to be operated jointly by the Principal Investigator and any other person nominated by the Institution. The funds will be released into this account by NHRC. However, if any institution is not in a position to open a separate

bank account for the research project due to any justified reason, then the funds will be released in the existing bank account of the Institution duly intimated by the latter to NHRC.

- 6.2. The sanctioned amount shall be released in three (3) installments as per the procedure given below:
 - 6.2.1. The first installment of 40%, i.e., ₹ 4,27,850/- (Rupees Four Lakh Twenty-Seven Thousand Eight Hundred and Fifty only) will be released after the receipt of the request for its release and particulars of the bank account opened for the purpose of the research project.
