ADMISSION NOTICE

Online applications are invited by the Dr. Ambedkar Centre of Excellence, Central University of Himachal Pradesh, Dharamshala under the scheme of Ministry of Social Justice and Empowerment, Government of India.

Courses:

- Group A and B examinations conducted by the Union Public Service Commission (UPSC)
- Group A and B examinations conducted by the State Public Service Commission (SPSC).

Duration of the course: One Year

Total seats for free coaching to SC and OBC students: 100 seats

Total paid seats for SC, OBC, General and other category: 25 seats

Beneficiaries of PM CARES Children Scheme: Unlimited

Eligibility criteria for students

- Students belonging to SCs and OBCs**, having total family income of Rs. 8.00 lakh or less per annum from all sources will be eligible for benefits under the Scheme.
- Age limit: **21-37**.
- Nationality: Indian Citizen
- Income Certificate:** Income declaration of self-employed parents/guardian should be in the form of a certificate issued by a Revenue Officer not below the rank of Tehsildar. Employed parents/guardians are required to obtain income certificate from their employer and submit consolidated certificate from Revenue Officer including any other additional source of income.
- Students having less than 50% marks in their class XII exam and graduation, shall not be considered under the scheme.
- The student will be required to provide a declaration that he/she has not taken benefit **more than twice** under the Scheme or any other similar coaching scheme run by the Central or State Government.
- The student should have a valid Aadhar number and a bank account seeded therewith, allotted to him/her.
- All beneficiaries of the PM CARES Children Scheme who have a certificate (with beneficiary ID) issued by the Central Government confirming their status as beneficiaries are eligible. **There will be no income or caste-related restrictions for such beneficiaries to avail of the benefits under this scheme**
- Beneficiaries of PM CARES Children Scheme will be exempted from entrance examinations.**

Reservation

The percentage of SC students shall not be less than 70%. In case of non-availability of adequate number of candidates in the SC category, the University can relax this 70:30 (SC/OBC) ratio. However, in no case, a less than 50% SC students shall be permitted. Also under each category, 30% of the slots shall be reserved for female candidates. In case sufficient numbers of female candidates are not available under any category, male candidates from the same category shall be considered by the University.

Selection Procedure:

The Common Entrance Test Conducted by the University and the merit list will be declared based on the test results.

Common Entrance Test Details:

Test Format: 100 Multiple Choice Questions (MCQs)

Total Marks: 100

Syllabus for the entrance test:

General studies (Indian History, Indian Art and Culture, Indian Polity, Indian Economy, Indian Geography, Science and Technology, Ecology and Environment and Current affairs) (70 Marks)

General English (10 Marks)

General Hindi (10 Marks)

Numerical ability and Reasoning (10 Marks)

Instructions to students:**a. For SC and OBC candidates under free coaching scheme**

1. The selected SC/OBC and PM CARES candidates will be paid Stipend @ Rs. 4000 per month for full duration of the course not exceeding one year i.e 12 months
2. Any candidate who will clear mains stage of Central Civil Services / State Civil Services Exams for Class 1 and Class 2 posts will be paid Rs. 15,000 as incentive for coaching for the interview.

b. For SC, OBC, General and other category students under Paid/Self-Financed coaching scheme

1. The students from SC, OBC, General or any other category may apply for the coaching however, these students have to pay the course fee of Rs.75000 per year and no stipend will be provided to them.

Note: No refunding of the fee will be done under any circumstances.
